conformity. In case of external audit, external experts of IQAC visit to all departments to check the performance in terms of quality of teaching and learning.

The internal audit frequency was decided once in a semester and external audit frequency was decided once in year.

#### 7. Suggestions from External Expert Members:

Mr. Nitin Bhide (External Expert, Industry) introduced the concept of 'Techathon' which is 24 hours project competition which could be arranged in our institute. During Techathon students get hands on experience on working with project idea and try to find a solution in a group. This enhances their technical skills and gives opportunity to work in a group.

The suggestion was given by Dr.Dhananjay Talange to organize conference in order to bring researchers, scientists, engineers, and scholar students together on common platform and to provide forum for the dissemination of research results, new ideas and practical development experiences.
