The Institute is well known for its Clean and Green campus. We have a lush green campus with around 540 trees with a Garden Land (Soil) area of 14851 Sq. meters. and a concrete paved surface area of 15,450/- square meters. Hence around 49% of the total area is covered with Garden Land (Soil). There are various trees planted on the institute premises which include Coconut, Neem, Badam, Mango, Rudraksh, Bamboo, Chapha, Gulmohar, Lemon, and Pomegranate to name a few. Organic fertilizers are used for all the trees. There are mechanisms to separate out paper, plastic and solid waste. Separate drums are provided for collection of recyclable plastic waste. Re-use of paper is done by the way of printing on both sides and shredding the paper to make art paper. Dry waste including paper / plastic is segregated and sent in vans to recyclable joints and/or PMC collection centers.

The internal communication of the Institute is through the Internet. There are hardly any day to day operations, where printing is required.


