3. Students motivated to be member of various professional bodies viz., (ACM, IEEE, CSI, Yi etc)
4. Students are also motivated to undergo professional certifications (MTA, Six Sigma etc)
5. An activity based learning method – Mini modeling is undertaken by each student which helps them to get insight into project
6. To participate in various Industry Techathon, Hackathon, etc.

Another effort to enhance the employability of the student in industry is through Internship and industry sponsor project in which we expect the students to learn the practical approach and understand the industry environment. Company is requested to allot project to the students or else depute the student on an ongoing activity/project, or they may be placed in different departments within the company to understand the flow of functions and interdepartmental responsibilities. This will save company efforts on training after employment and students will deliver fast once he/she will join the company.
