

For the A.Y. 2021 – 22 Eligibility Criteria to avail benefit of Govt. Scholarship Scheme:

Sr. No.	Eligibility Criteria
1.	For the A.Y. 2021 – 2022 Regular students admitted through CAP Round under Reserved Category (SC, ST, SBC, SEBC, DT-VJNT, OBC and EWS), Minority Community Students (Parsi, Sikh, Muslim, Christian, Jews) and Open Category students eligible to apply for Govt. Scholarship scheme on MahaDBT Portal.
2.	For SC & ST Category - Parent's Annual Income No Limit For SBC, SEBC, DT-VJNT, OBC, OPEN, EWS Category - Parent's Annual Income limit is Rs. 8,00,000/- (Rs. Eight Lakhs Only) For Minority Community - Muslim, Sikh, Buddhist, Christian, Parsi, Jain & Jews -Parent's Annual Income limit is Rs. 6,00,000/- (Rs. Six Lakhs Only)
3.	Students who have 2 Years or more than 2 Year GAP after the A.Y. 2015 - 2016, are not eligible to avail Benefit of any Govt. Scholarship Scheme.
4.	Applicant should be Domicile of Maharashtra State.
5.	Students are required to maintain minimum 75% attendance throughout the A.Y. 2021 - 2022.
6.	For the A.Y. 2021-22, all eligible students are required to fill up an online scholarship form on MahaDBT Portal - https://mahadbtmahait.gov.in/login/login along with scanned copy of all original mandatory documents within stipulated time limit to avail benefit of Govt. Scholarship Schemes. After completion of online scholarship form fill up process on MahaDBT Portal, only eligible students are required to send soft copy of MahaDBT online form along with scanned copy of original mandatory documents on scholarship@isquareit.edu.in within stipulated time limit to avail benefit of Govt. Scholarship Scheme.

Most Important Note:

It is mandatory for all Eligible and Regular Students who have taken admission through CAP Round under Reserved Category (SC, ST, SBC, SEBC, DT-VJNT, OBC and EWS) to fill the scholarship online form on MahaDBT Portal and send soft copy of the same along with mandatory documents on scholarship@isquareit.edu.in within stipulated time limit.

Failure to complete the above process, student / parent will be liable to pay full Fee for the A.Y. 2021 - 2022 to the Institute's Accounts Section.

Please note, students who have taken admission through CAP Round under Reserved Category (SC, ST, SBC, SEBC, DT-VJNT, OBC and EWS) but Not eligible to apply on MahaDBT Portal for Govt. Scholarship scheme due to Income limit, unavailability of above mentioned mandatory documents or GAP more than 2 years are required to send a clarification mail on scholarship@isquareit.edu.in and also need to pay full Fee for the A.Y. 2021 - 2022 to the Institute's Accounts Section.
