Regular students admitted through CAP Round under Reserved Category (SC, ST, SBC, SEBC, DT-VJNT, OBC and EWS), Minority Community (Parsi, Sikh, Muslim, Christian, Jews) and Open category students are required to go through below mentioned eligibility criteria before starting to fill online Govt. Scholarship Scheme form on MahaDBT Portal <https://mahadbtmahait.gov.in>**

**It is mandatory for all eligible students to have scanned copy of their all original documents, photograph in JPG / PDF format (with clarity) & Size less than 125 KB to upload on MahaDBT portal during online form fill up process.**

1.	For the A.Y. 2021 – 2022 Regular students admitted through CAP Round under Reserved Category (SC, ST, SBC, SEBC, DT-VJNT, OBC and EWS), Minority Community Students (Parsi, Sikh, Muslim, Christian, Jews) and Open Category students eligible to apply for Govt. Scholarship scheme on MahaDBT Portal.
2.	For SC & ST Category - Parent's Annual Income No Limit For SBC, SEBC, DT-VJNT, OBC, OPEN, EWS Category - Parent's Annual Income limit is Rs. 8,00,000/- (Rs. Eight Lakhs Only) For Minority Community - Muslim, Sikh, Buddhist, Christian, Parsi, Jain & Jews - Parent's Annual Income limit is Rs. 6,00,000/- (Rs. Six Lakhs Only)
3.	Students who have 2 Years or more than 2 Year GAP after the A.Y. 2015 - 2016, are <b>not</b> eligible to avail Benefit of any Govt. Scholarship.
4.	Applicant should be Domicile of Maharashtra State.
5.	Students are required to maintain minimum 75% attendance throughout the A.Y. 2021 - 2022.
6.	<b>For the A.Y. 2021-22, all eligible students are required to fill up an online scholarship form on MahaDBT Portal - <a href="https://mahadbtmahait.gov.in/login/login">https://mahadbtmahait.gov.in/login/login</a> along with <u>scanned copy of all original mandatory documents</u> within stipulated time limit to avail benefit of Govt. Scholarship Schemes.</b> <b>After completion of online scholarship form fill up process on MahaDBT Portal, only eligible students are required to send soft copy of MahaDBT online form along with scanned copy of original mandatory documents on <a href="mailto:scholarship@isquareit.edu.in">scholarship@isquareit.edu.in</a> within stipulated time limit to avail benefit of Govt. Scholarship Scheme.</b>
