

INSTRUCTIONS FOR REPORTING AT THE INSTITUTE For First Year (Academic Year 2021 – 22)

The students have to report to the academic building for Document verification and completion of Admission Process. All candidates should bring following **original documents** along with **TWO set of self-attested photocopies**. **Also, scanned copy of all the original documents has to be bought on a Pen Drive.**

The original documents hard copies would be retained by the college for the purpose of DTE / ARA Verification. The soft copy of the documents are required to be kept with students till the completion of the course (till Course Completion).
