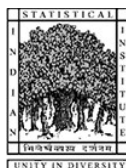

I am pleased to inform you that you have been selected for admission to the Master of Technology in Computer Science, of Indian Statistical Institute, Kolkata, for the academic session 2020-21, subject to satisfying the necessary eligibility conditions and being declared medically fit by the Medical Officers of the Institute.
