ONLINE FORM FILLING PROCESS OF GOVT. SCHOLARSHIP SCHEME ON MAHADBT PORTAL FOR THE A.Y. 2023 – 2024

Dear Students,

Please note, **it is mandatory for regular students admitted through CAP Round under Reserved Category** (SC, ST, SBC, SEBC, DT-VJ, NT1 (NT-B) / NT2 (NT-C) / NT3 (NT-D), OBC and EWS) **to fill online Govt. Scholarship Form for the A.Y. 2023 - 2024 on MahaDBT Portal.**

Regular students admitted through CAP Round under Reserved Category (SC, ST, SBC, SEBC, DT-VJ, NT1 (NT-B) / NT2 (NT-C) / NT3 (NT-D), OBC and EWS), **failure to complete the online Govt. Scholarship Form on MahaDBT Portal within stipulated time limit, student / parent will be liable to pay full Tuition Fee for the A.Y. 2023 - 2024 to the Institute's Accounts Section.**

It is mandatory for all eligible students to have scanned copy of their all original documents, photograph and signature in JPG / PDF format (with clarity) & Size less than 125 KB to upload on MahaDBT portal during online form filling process on MahaDBT Portal.

Kindly note, before starting to fill online Govt. Scholarship Scheme form on MahaDBT Portal <https://mahadbtmahait.gov.in> students are required to go through mentioned Eligibility criteria, List of mandatory documents to avoid any inconvenience.
