Standard Terms and Conditions

1. Fees and charges listed in the above table are for the standard duration of the relevant Academic Year. The students residing in the Institute hostels will be required to entirely vacate the hostels at the end of the relevant Academic Year.
2. All fees and charges listed are in Indian Rupees (INR) unless stated otherwise. Payment of all fees and charges are to be made by way of electronic transfers only (RTGS / NEFT / Net Banking / Cards / UPI). Any other mode of payment of fee and charges is not acceptable.
3. The payment of total hostel and mess charges along with refundable deposits mentioned in the above table is "MANDATORY" for all students interested to avail the Institute hostel facility for the applicable and chosen occupancy. Refundable deposits, if any, shall be processed at the end of the course subject to No Dues Certificate from all concerned departments of the Institute.
4. Mess charges are subject to revision based on market conditions, food commodity prices, fuel charges, and operational expenses. Meals missed by students due to absence, leave, holidays, examinations, internships, industrial visits, illness, or personal reasons shall ordinarily not qualify for refund or adjustment. The Institute/Mess Committee reserves the right to modify menu, timings, service pattern, or contractor arrangements without prior notice. Students shall maintain decorum and hygiene standards in dining areas.
5. Separate hostel facilities / floors may be designated for boys and girls.
6. The student will be required to forfeit the hostel, mess and laundry charges for the entire semester in case he / she opts to withdraw from availing the student hostel and mess facility post allotment and occupation of the student hostel. No refund request/s whatsoever shall be entertained in this regard.
7. The Institute reserves the right to impose late payment charges and interest on overdue fee amounts as deemed appropriate. The levy of such late fee, interest and penalties, if any, shall not prejudice the Institute's right to initiate disciplinary, administrative or recovery proceedings.
8. The decision of the Institute Management in all hostel and mess related matters shall be final and binding. The Institute reserves the right to amend hostel fees, mess charges, rules, facilities, occupancy norms, and policies at any time without prior notice. Disputes, if any, will be administrated strictly under the limits of Pune Jurisdiction only.
